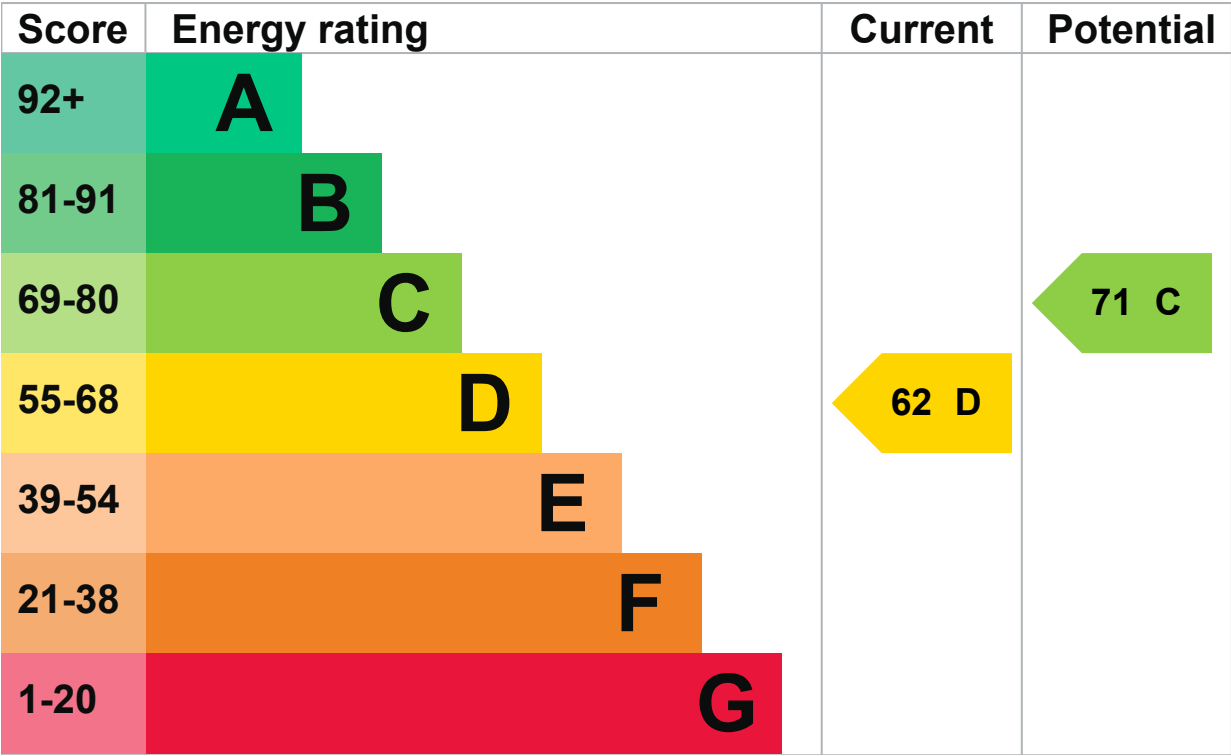

How this affects your energy bills

An average household would need to spend **£1,583 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

Yes. Each step builds on the one before it so you can save the most energy.
